

Introduction

With the changes implemented in April 2014 by The Taking Control of Goods Regulations 2013 and the enactment of Part 3 of the Tribunals, Courts and Enforcement Act 2007, High Court Enforcement Group decided to expand its in-house training to prepare enforcement agents and office-based staff.

Level 2 award:

Taking control of goods

Award level: Level 2

Course duration: one month preparation and two days classroom

Awarding body: CILEx

A CILEx endorsed programme

Who should attend

This qualification is for new entrants into the industry and also for existing enforcement agents wishing to upskill their knowledge of new relevant legislation, or any other individual involved in the practice of Taking Control of Goods.

The qualification fully meets the requirements of The Certification of Enforcement Agents Regulations 2014 and aims to establish the knowledge required by law to obtain an enforcement agent's certificate to practice.

Preparation and assessment

Delegates will be given a reading document, and a help line number, to prepare themselves approximately one month before the course. On the course delegates will be given workbooks to prepare for the exam.

The one hour qualifying exam involves 60 multiple choice questions. The pass mark is 75%.

The modules

- ▶ The role of the enforcement agent
- ▶ Law relevant to enforcement agents
- ▶ Practice of taking control of goods
- ▶ Practice of removal and sale of goods
- ▶ Aspects of customer care relevant to an enforcement agent
- ▶ How to recognise, assess, defuse, resolve and reduce risk in conflict situations

The course fee

£495.00 + VAT per person for the two-day course including examination on the second day, refreshments and lunch. Accommodation is not included.

It may be possible, depending on prior experience, to purchase the pre-examination reading material for £75.00 + VAT or to just sit the exam for £94.00 + VAT.

Level 2 award:

Execution of criminal warrants of control and arrest

Award level: Level 2

Course duration: one month preparation and one day classroom

Awarding body: CILEx

A CILEx endorsed programme

Who should attend

The qualification is for anyone involved in the execution of criminal warrants of control (and arrest) issued under section 76 of the Magistrates' Courts Act 1980 and using the powers conferred under Schedule 4a of the Magistrates' Courts Act 1980.

The modules:

- ▶ Understanding violence and conflict management
- ▶ Modern slavery
- ▶ [Criminal] warrants of control
- ▶ [Criminal] warrants of arrest

Preparation and assessment

Delegates will be given a reading document, and a help line number, to prepare themselves approximately one month before the course.

The one hour qualifying exam involves 60 multiple choice questions and a practical activity in searching an arrested person. The pass mark is 75%.

The course fee

£350.00 + VAT per person for the one-day course including examination, refreshments and lunch. Accommodation is not included.

Level 3 award:

Taking control of goods & civil enforcement

Award level: Level 3

Course duration: one month preparation and one day classroom

Awarding body: Agored Cymru

A Qualification Wales Regulated Qualification

Who should attend

This award is aimed at experienced enforcement agents who wish to develop their skills and knowledge. It also forms part of the educational pathway towards becoming an authorised High Court Enforcement Officer.

The objective is to build on knowledge already gained from the Level 2 qualification for Taking Control of Goods and to raise standards and improve quality in the enforcement profession. It is the only regulated award available in the UK covering CRAR and warrants of arrest.

The modules:

- ▶ Vulnerability & mental health
- ▶ Warrants of control and arrest (Magistrates Courts Act 1980)
- ▶ Commercial Rent Arrears Recovery (CRAR)

Preparation and assessment

We suggest one month absorbing the reading material. There is a one-day classroom attendance for training and assessment of Vulnerability and Mental Health Awareness and a practical assessment of searching an arrested person (after training). The Commercial Rent Arrears Recovery (CRAR) assignment will be explained on the day. A further month will be given to complete the assignment (fully referenced) of approximately 1,500 words.

You will be supplied with pre-course reading material and a help line number should you get into difficulty. On the course you will also be supplied with a workbook to support your evidence portfolio. There is no pass mark; successful completion is based on evidence portfolio and assignment.

Level 3 award:

Vulnerability & mental health awareness in relation to enforcement practices

Award level: Level 3

Course duration: one month preparation and a half day classroom

Awarding body: Agored Cymru

A Qualification Wales Regulated Qualification

Who should attend

Enforcement agents, welfare team managers and debt managers wishing to improve their understanding of and approach to vulnerable debtors.

This is the only regulated award available in the UK for vulnerability and mental health awareness. The objective is to build on knowledge already gained from the Level 2 qualification for Taking Control of Goods and to raise standards and improve quality in the enforcement profession.

The modules:

- ▶ Defining vulnerability
- ▶ Mental health problems
- ▶ Mental capacity
- ▶ Procedures & risk factors
- ▶ Enforcement vulnerability: legal background
- ▶ Mental health documentation

Preparation and assessment

Successful completion of the award involves a half day classroom course involving written answers to questions and an evidence portfolio. The course will be held at the Group's Colwyn Bay headquarters and other strategically placed outreach centres.

Award level: Level 3

Course duration: one month preparation and one day classroom

Who should attend

Enforcement agents and those involved in the removal of protesters and the enforcement of writs of possession, and other remedies including forfeiture, for the recovery of property or land.

Preparation and assessment

We suggest one month absorbing the reading material. There is a one day classroom attendance for training and assessment.

The course fee

This qualification is in the final stages of assessment and will be available in 2019.

Frequently asked questions

How do I register for the exam?

This is a one-step process and involves completing and returning the registration form via e-mail: training@excelenforcement.co.uk.

When can I take the exam?

Examinations take place monthly (or by special appointment depending on numbers). For more details e-mail: training@excelenforcement.co.uk.

Where can I undertake qualification and sit the exam?

Training courses and examinations are held in Colwyn Bay and other outreach centres. Assessment is in English.

For group bookings we can offer on-site training and examination at a discounted group rate. For more details e-mail: training@excelenforcement.co.uk.

When will I receive my results and certificate?

You will receive your results within 48 hours. Your results will be in the form of a report which details your percentage of correct answers for each learning outcome.

If successful, your qualification certificate will arrive by post within 14 days of completing the qualification/ course.
